GENERAL INFORMATION

File Frequency: Daily
 Record Size: 4500 characters
 Form Name: CRMA (Daily updates) ICRM (Initial full file)

DESCRIPTION

The CRM Activity file (CRMA) is created on a nightly basis and contains activity on CRM notes. ICRM is sent on the first night to establish a baseline of notes.

The “A” Record contains generic information about the note.

The “B” Record contains the text of the note (there can be a maximum of 9,999 iterations of the “B” record for each note).
