DESCRIPTION

The Disclosure Statistics (SEC6) file is created quarterly, two to three weeks after the first Saturday of the quarter-end. It contains order routing statistics for each Introducing Broker Dealer (IBD) by venue. It includes counts and percentages of market orders, limit orders, and other orders for quarterly data.

This is a fixed length, delimited file, which uses double quotation marks (") and semicolons (;) as field separators.

IMPORTANT NOTE: Only firms that execute some or all equity or option trades away from Pershing should elect to receive this file. For IBDs that execute 100% of trades through Pershing, the disclosure will be hosted on a Pershing website using the following URL: www.orderroutingdisclosure.com.
